IX. COMMITTEE AND OFFICIAL REPORTS

1. Senior Commission meeting on May 20, 2019

- Mr. Hilberg reported the Commission discussed the upcoming events: a police safety
 presentation in June; elder law presentation in July; brain health presentation in August;
 holistic sleep presentation in September; and phone app presentation by Madeira High

2. Planning Commission meeting on May 20, 2019

- Mr. Moormann reported there were no hearings on the agenda. Carly Chu was appointed to Planning Commission, filling the unexpired term of Mark Scheid.
- There was additional public comment on the Comprehensive Plan and discussion by the Commission. Envision has been asked to make revisions to the Plan based on comments received. The intention is to discuss the Plan at the June meeting and then advance it to Council.

• The term of the chair was discussed and the Commission decided to have a two-year term.

3. Police Report

- Chief Schaefer reviewed the April statistics and noted that officers have been out in neighborhoods advising motorists to drive safely in advance of citing for infractions.
- Chief attended the Ohio Chiefs Conference in Columbus and reviewed some of the sessions in which he participated. Officer Joe Freeman attended an investigator's course.
- Thanks were extended to all the agencies that helped with the recent missing person case, including the Madeira Indian Hill Joint Fire District. The Department's ATV was used to navigate the trails and move people and dogs efficiently.
- Three new auxiliary officers have been added to the Department.
- A speed study was conducted on Hosbrook and speeds are again an issue; there will likely be traffic enforcement like was conducted late last year. A study was also conducted on Euclid near the Fowler crosswalk. The speeds were not found to be much of an issue; new crosswalk signs have been installed on the double-yellow line to bring attention to this crosswalk and others in the City.

XI. ORDINANCES AND RESOLUTIONS

- 1. Res. No. 21-19: Authorizing the City Manager to Execute an Agreement with Duke Energy Ohio for the Installation of Decorative Street Lights on Camargo Road
 - Mr. Moeller said the resolution was tabled at the last meeting to investigate funding opportunities. The State would have funds available for projects that move to more efficient lights, but the minimum cost was higher than the expected cost for this project. Mr. Moeller also spoke with Duke Energy who said they would assist the City in applying for funds that may be available for changing the bulbs in the fixtures on Miami as well as others around the City.
 - Motion to put Res. 21-19 on the floor was by Mr. Moormann.
 - Mr. Moormann suggested that an energy audit take place to look at all the fixtures in the
 City including field lights and traffic signals. Grants for an audit are available from the
 State.
 - Adapting the lights on Camargo Road to shield residences from light was discussed, as was the color of the fixtures.
